- 4. Deduct from my account and/or cash bond expenses for restoration/repair of the sidewalk, drainage and street as well as any damage suffered or sustained by other residents;
- 5. Forfeit or deduct from my account and/or cash bond penalties levied for violations discovered/noted, in accordance with the schedule provided me;
- 6. Bill me in case my cash bond shall not sufficiently cover all the expenses and penalties for which I am responsible by reason of my applied-for project;
- 7. Obligate me ₱1,000.00 per day for failure to rectify any violation of the BAVA Deed of Restriction and Building Rules and Regulations. This amount shall not be deducted from the posted cash bond;
- 8. Prohibit entry of workers except if the works to be conducted is for the rectification of violation.
